I. FOREIGN EXCHANGE SERVICE

I.1 Foreign Exchange Service

I.1.1 Regulations (T)

- I.1.1.1 Foreign Exchange Service permits a customer to obtain exchange service from an exchange service from an exchange outside the Local Exchange Area in which the customer is located.
- I.1.1.2 Foreign Exchange Service is offered in connection with flat rate individual line main station service and flat rate PBX service, and Centrex type service only, as offered by the local exchange carriers in Georgia.
- I.1.1.3 The exchange service portion of this offering is furnished at the same rates and subject to the regulations applying in the exchange from which the subscriber is served. In addition, any restrictions to the use of the exchange service portion by other than the Foreign Exchange Service subscriber and his representatives also apply.
- I.1.1.4 The initial service period for the service is three (3) months.
- I.1.1.5 A Special Access Surcharge applies to each termination of a channel service at a PBX or equivalent device capable of interconnecting the channel with the local exchange network. The surcharge applies to each multipoint termination at a customer's location. See Section 3 of the Exchange Carrier Association Tariff No. 1 for regulations concerning the Special Access Surcharge including provisions for exemption.
- I.1.1.6 All Foreign Exchange Service circuits will be toll restricted at the point of dial tone origination.

I.1.2 Rates and Charges (T)

- I.1.2.1 The rate for Foreign Exchange Service is the monthly rate for individual line main station or private branch exchange service applicable within the base rate area of the serving foreign exchange in addition to mileage charges for each circuit as follows:

I.1.2 Rates and Charges (Cont'd)

I.1.2.1 (Cont'd)

- A. Where the customer for Foreign Exchange Service is so located that it would be more economical for the Telephone Company to provide the Foreign Exchange Service direct from the foreign exchange to the customer's location by the extension or utilization of existing plant:
- (1) For the distance from the customer's location to the central office in the foreign exchange area from which service is received, a mileage charge of \$4.25 per month per mile or fraction thereof, route measurement, will apply.
- B. Where the customer for foreign exchange service is so located that it is not economical for the Telephone Company to provide foreign exchange service direct to the customer's location by the utilization of existing plant.
- (1) For the distance from the central office of the exchange from which the customer would normally receive service to the central office from which service is furnished, a mileage charge of \$4.25 per month per mile or fraction thereof, route measurement, will apply.
 - (2) In case the customer is located outside the base rate area of the exchange from which he would normally be served, exchange line mileage charges as specified in Section C of this Tariff will apply in addition to the foreign exchange mileage charges.

I.1 Foreign Exchange Service (Cont'd)

I.1.2 Rates and Charges (Cont'd)

I.1.2.2 For tie lines connecting private branch exchange switchboards in different exchange areas, a mileage charge of \$4.25 per month, per mile or fraction thereof, route measurement, between switchboards will apply to each line.

I.1.2.3 The charge for individual private branch exchange stations connected for foreign exchange service is the monthly rate applicable for other private branch exchange stations connected to the same private branch exchange switchboard, in addition to a mileage charge of \$4.25 per month, per station per mile or fraction thereof, based on route measurement between the station and the switchboards.

I.1.2.4 Where any special equipment used for signaling purposes or any special treatment used at the central office end or station end is required, 1/24 of the cost of equipment and installation will be calculated and billed on a monthly basis.
